OFFICIAL NOTICE

According to Section 28E – Wage and Fringe Benefit Increase of the 2014-2019 Laborers' Master Agreement the Union may elect at its option to allocate each increase to any or all of the following: Wages, Health and Welfare, Pension/Annuity, Vacation-Holiday-Dues Supplement, Training-Retraining/Apprenticeship or Laborers-Employers Cooperation and Education Trust (L.E.C.E.T.). Therefore, effective June 27, 2016, a one dollar fifty cents (\$1.50) per hour wage and fringe benefit increase will be allocated as follows:

June 27, 2016 – Wage and Fringe Benefits Allocation:

Wages	additional	\$0.50 per hour
Health and Welfare	additional	\$0.30 per hour
Annuity	additional	\$0.68 per hour
Training	additional	<u>\$0.02</u> per hour
Total	additional	\$1.50 per hour

June 27, 2016 – Labor Foreman Rate (no change):

\$2.00 per hour above any classification in this Agreement working under his/her direction.
