According to Section 28E – Wage and Fringe Benefit Increase of the 2014-2019 Laborers' Master Agreement the Union may elect at its option to allocate each increase to any or all of the following: Wages, Health and Welfare, Pension/Annuity, Vacation-Holiday-Dues Supplement, Training-Retraining/Apprenticeship or Laborers-Employers Cooperation and Education Trust (L.E.C.E.T.). Therefore, effective June 26, 2017, a one dollar sixty cents (\$1.60) per hour wage and fringe benefit increase will be allocated as follows:
